Kadri Simson - European Commissioner for Energy

Kadri Simson is an Estonian politician from the Centre Party. She is serving as a European Commissioner for Energy in the von der Leyen Commission since 2019. She was previously the Minister of Economic Affairs and Infrastructure in Jüri Ratas' first cabinet from 2016 to 2019. During the Estonian Presidency in the Council of the EU, Kadri Simson chaired both energy ministers and transport ministers meetings in TTE Council and ministers of economy format in EU Competitiveness Council. From 2007 to 2016 Kadri Simson was a member of the 11th, 12th, and 13th Riigikogu and in 2019 she was also elected to the 14th Riigikogu.



Harmen Dekker - CEO, European Biogas Association

Harmen Dekker has worked for almost 15 years within the sustainability sector and is devoted to the mitigation of climate change. With both a technical as well as a business administration background he has built his career in the water and gas sector, where he has held various management positions.
